Per our bylaws, the PTO will hold elections for the entire Board on May 4th, 2021. We are eager to have a slate of engaged and enthusiastic people who are ready to hit the ground running as we transition back to a more "normal" school year!

Nominating and Election Timeline

- Wednesday, March 31st by 5pm (firm!) - [Self-Nominations](#) Due
- Monday, April 12th - Candidates and Personal Statements posted to PTO website
- Tuesday, May 4th - Election Day. CSI Community votes!

Eligibility

- Must be a current member of the CSI PTO (All current CSI parents and guardians are members of the PTO)
- Parents and guardians of students who have been in the district year-long Distance Learning program are not eligible to run
- Parents and guardians of students who will be new to CSI during the 2021-22 school year are not eligible to run
- Year-long Distance Learning and incoming parents and guardians are welcome to participate in the PTO in one of the many roles that will be open next year (i.e. committee chairs, committee members, etc.)

General Requirements

Being on the PTO is a commitment and, in addition to the responsibilities of each position, members of the PTO Executive Board should expect the following:

- Attend 1 Board meeting per month
- Attend 1 General meeting per month
- Attend subcommittee meetings as needed

In the past PTO Board and General meetings have been on Tuesday or Wednesday evenings, and at this point we expect them to be on Zoom for a while. Once the new Board is in place, members of the Board can work together to identify the best day/time for meetings. Attendance at all meetings is mandatory.
